Short Term Rental Agreement and Rental Rules (minimum 30 night rental)

This Short Term Rental Agreement (the "Agreement") is made by and between Rael Donde of Metropolitan Oasis Investments ("Homeowner") and **YOURSELF** ("Guest") as of the date last set forth on the signature page of this Agreement. For good and valuable consideration, the sufficiency of which is acknowledged, the parties hereby agree as follows:

1. Property: The property is located at:

- **2. Rental Party:** The rental party shall consist of Guest and the number of additional persons specified in the booking inquiry:
- **3. Maximum Occupancy:** The maximum number of guests is limited to the number specified in your inquiry. An additional charge or \$50 per person per night for guests in addition to this limit will be assessed.
- **4.** Term of the Lease: The lease begins at **3 p.m.** on the agreed booking check-in date (the "Check-in Date") and ends at **9 a.m.** on the agreed booking check out date (the "Checkout Date").

8. Rental Rate and Fees

a. Deposit: A deposit of \$850 is due at time of booking.
